**Approve Agenda**

Comm. Williamson motioned to approve the agenda. Comm. Nordlof seconded, and the motion carried unanimously.

**Approval Of Minutes - August 3, 2022**

PBS was on-site filming for Wisconsin Life and Uniquely Wisconsin. The segments will air sometime this fall. The Milton House Museum has also hosted a few different travel writers.

Director Cushman stated the Underground Railroad proclamation was read by Mayor Welch on September 6.


**Set Next Meeting Date**
